## School Trips and Extra-Curricular Activities Consent Form

School trips and extra-curricular activities form an essential part of your child's learning. We want to make the process of gaining consent for trips and extra-curricular activities simpler.

Parents or carers with parental responsibility can sign their child up for a trip or extra-curricular activity through My Child at School (MCAS) under Clubs and Trips. Parents will be informed of the details of the trip or club through MCAS. The trip letters will make it clear the details of the trip, costs if applicable and the cancellation policy.

By enrolling your child on a visit or extra-curricular activity through MCAS, you are providing the necessary consent, as only the parent or carer with parental responsibility has the ability to do this. Furthermore, we ask the parent or carer with parental responsibility to complete the one-off, attached consent form, which we will hold on record.

This means we will **no longer send out permission slips routinely for every trip or extra-curricular activity**. Staff may need to send out different consent slips that are specific to each visit, for example, waivers for adventurous activities providers or social media consent forms from providers.

Please return the attached consent form to either student reception (if a student) or visitors' reception (if a parent or carer). If you have any questions, please contact me on the above details.
